# Introduction

Migration is a *necessary* phenomenon of contemporary societies. It is so in the broadest sense as a historical fact and structural dynamic of a globalized and unequal world. It is also so in the more specific sense related to the economic and social sustainability of both origin and destination countries. Among the latter, the context of the European Union represents a paradigmatic case. During the years of the "refugee crisis", on average, each migrant contributed more than 1,500 euros net to the economy of the member states; 47 times more than the native population (Fiorio et al. 2022<sup>1</sup>). The aging population, the reduction of the native workforce, and the deterioration of fiscal variables make immigration an irreplaceable asset for the progress of the EU (Defensor del Pueblo, 2020).

In Spain, the most significant impact of immigration has been demographic, with a growth of 8 million people since the beginning of the century, exclusively due to immigration growth. However, this growth has not been accompanied by an increase in productivity. Between 2000 and 2022, in fact, the gap between the Spanish GDP per capita and that of the rest of the EU-15 countries has widened (González Enriquez 2024<sup>2</sup>). This result points to structural limits of the Spanish productive model, which constrain the benefits and opportunities of immigration and harm the rights and opportunities of migrants. As noted in the report on the Integration of the Foreign Population in the Spanish Labor Market (Maia and Medina, 2022<sup>3</sup>), the average salary of foreign workers from Africa is 34% lower than that of Spaniards. This gap widens in the case of women. The combination of lower employment and stagnation in low-skilled (and low-paid) jobs places a consistent part of the immigrant population at risk of poverty or even material deprivation.

The migration phenomenon also has crucial consequences in the countries of origin. The impact can be positive, if we think, for example, of the aggregate effect of remittances on economic, social, and political progress in home countries, as recently demonstrated by Escribá-Folch, Wright, and Meseguer (2022<sup>4</sup>). But it can also be negative, depriving the countries of origin of human capital. Ebeye and Lee (2023<sup>5</sup>), for example, have very clearly detailed how the brain drain phenomenon in the health sector negatively affects the development dynamics of African countries, weakening their health systems.

The impact of migration on destination countries, origin countries, and the lives of migrants is the result of a complex system of agency, institutional, and structural elements that vary over time and geographically. This complexity requires careful reflection by all policymakers and stakeholders involved in migration governance, in order to limit its negative consequences and enhance its positive effects.

Such reflection, however, seems increasingly difficult in the current political debate, marked by growing polarization and focused exclusively on border control and the fight against irregular immigration.

This event seeks to advance in the opposite direction, bringing together experts for a shared reflection on the challenges and ways to improve migration governance between Africa and Europe. In doing so, it follows a precise approach: 1) Directed at Sub-Saharan African countries, not only as a key origin of migratory flows, especially along the Canary route, but also as key institutional interlocutors for Spain and the European Union, bearers of essential interests and perspectives for the sustainability of migration governance; and as sources of inspiration, as receiving countries in the African context. 2) Pragmatic, focused on empirical evidence as an indispensable condition for fair, viable, and effective governance, and oriented towards existing good practices in both origin and destination countries. 3) Focused on work, as a fundamental dimension of integration and an essential prerequisite for social cohesion.

#### Structure and Methodology

The meeting is structured into three thematic closed-door roundtables. The debate will revolve around key questions related to each theme. The objective is to identify shared guidelines to improve migration and integration governance, as well as their political and institutional narratives. The first two roundtables will follow the same format: diagnosis of the African, Spanish, and European contexts, followed by a debate on the main challenges and solutions. The third roundtable will be an open debate based on practical cases and involving participatory exercises.
